## LEGAL PROCESS



### LEGAL PROCESS

**Justice of the Peace:** You will need to meet with a Justice of the Peace to review and sign your Marriage License Application. On your first business day after arrival, you can apply for your marriage license. Processing typically takes 1-2 business days.

**Submission:** The completed application and original documents will be submitted to the Legal Department at Government Headquarters.

**Officiant:** The ceremony must be performed by a registered marriage officer of the Federation of St. Kitts & Nevis (a member of the clergy or a Magistrate). Our current packages cater to a magistrate as the wedding officiant.

The Wedding officiant (magistrate) will present the license to the High Court for registration.



### LEGAL FORMALITIES

Tying the rental knot in St. Kitts is a wonderful, unique experience, but there are some legal procedures which are necessary. Our Events Department is available to assist you with these arrangements to ensure that you have the special day spot.

#### REQUIRED DOCUMENTATION:

**Identification:** Valid passports and original or certified copies of birth certificates for both parties. Please ensure the names on both documents match exactly.

**Marital Status:** If applicable, original or certified copies of a Decree Absolute (divorce certificate) or a Death Certificate for a deceased spouse.

**Translations:** Any documents not in English must be accompanied by a notarized translation.

### POST CEREMONY REGISTRATION
